June 20, 2023

 - b. Ashley Brown, Planning and Development Officer of Capital Region Service Commission (CRSC), presented the following cases:
 - Dragon Mire Farm Petting Zoo, 571 Whittaker Road, FILE#0125-06-2023-V.b.1
 - 1. The First Case: 571 Whittaker Road
 - a. It is the council's decision not to support the application for the "Kennel" and is requesting that the CRSC honor the "Rural Plan" for Ward 2 as it is written and not provide exceptions to the rural plan. The property does not comply with the 2 hectares requirement in section 3.18 (a). FILE # 0100-06-2023-Vbi1.a

b. They also only approve the Hendersons operating a "Backyard Agriculture Operation" per the Rusagonis-Waasis Rural Plan and their zoning (which is Rural Residential). This limits them to a total of 10 hens and/or rabbits. The council requests, as per the rural plan, that the Hendersons must also have a roofed enclosure with a chicken coop connected to a chicken run, fully enclosed, visually screened from the street and neighbouring properties and all manure/waste needs to be composted or removed (see section 3.21 of the Rusagonis-Waasis Rural Plan). This is equivalent to 0.4 animal units, with the additional limitation of only hens and rabbits. FILE # 0100-06-2023-Vbi1.a
