First Special Council Meeting 2023-2026 Term

1. Calling to order

Mayor David Hayward called the Special Meeting to order at 6:30 p.m.

2. Approval of the Agenda

Moved by Councillor Gilles Turner and seconded by Councillor Dr Sheppard to approve the agenda.

3. <u>Capital Region Service Commission- Regional Development Officer Ashley Brown</u> (Speaker) for the Terms & Condition of <u>Tina & Kevin Hansen property</u> in Ward 1 of Sunbury-York South Rural Community- Consideration of terms and conditions for agriculture use and variance is setback distances for a livestock facility in the Residential – Two Zone of the New Maryland Planning Area Rural Regulation – Community Planning Act.

Ashely Brown spoke on behalf of the CRSC to explain the situation such that there was a complaint submitted to CRSC by the next-door neighbor not being able to have a quality of life on his property due to the fact that his neighbors (Tina & Kevin Hansen) rooster. Ms. Brown stated that the CRSC does," a courtesy thing" to come to you guys (Council) to ask the council if there is any comments or concerns and need to know if council is in support or not and to give recommendations to PRAC staff to help them make their decision on this. - 2. The property variance changes to allow for the relocation of the chicken coup to be 30.86 M from the property lines.

The question is "Does council agree or not agree to approve a 30.86-metre variance in a rear setback to locate a livestock facility 9.14 meters from the rear property line with PID 75343731; and approve a 33.91-meter variance in a side setback to locate a livestock facility 6.09 meters from the shared property line with PID 75290544.

4. Consideration of the New Proposed crest for Sunbury-York South Rural Community
